

Dear Fellow Citizen,

The direness of our present, rapidly-deteriorating political-economic situation augurs, for us, that we can no longer afford to be *vague* about what we are fighting for -- about what we hold to be the detailed definition of "democratic socialism", of "free and democratic associations of producers", of '***political-economic democracy***', or of 'Equitism' -- of whatever name we should decide for our goal: a "eu-catastrophic" way out of the now accelerating, 'mal-catastrophic' descent into a nightmare world of totalitarian, humanocidal, perpetually warring national state-capitalisms that George Orwell foresaw, and that is otherwise the prevailing ["new world"] order of the day.

The enclosed draft constitutional amendment, designed to implement what we call '***The Equitarian Reform***', and designed to induce a social revolutionary transition from the present, proto-totalitarian, proto-state-capitalist polity, to a trans-capitalist '***political-economic democracy***', is the result of an immanent critique of the U. S. constitution, and of the advanced-decadent, monstrous [state-]capitalist society which the U. S. is becoming, apace, before our very eyes, aghast. It is framed in terms of the U. S. constitution, but is designed to be readily adaptable for '***The Equitarian Reform***' of other national constitutions. It is oriented toward an *international* realization of what we term '***political-economic democracy***', as the successor system to the present, descendant phase capitalist system.

Of course, without a movement of millions behind it, this proposed social reform -- let alone social revolution -- is not, visibly, much more than some tiny, dried ink pools, staining some pages.

But we hold that a clear view of the successor system that people such as yourself, and such as we, are so desperately seeking, may be a crucial key toward eventually motivating millions to take seriously the possibility of their, and of many others, self-salvation, through a global movement for a global renaissance of human flourishing, enabled by global collective construction of a successor system to the present, dying socio-economic system, with its suicidal ruling class, one which threatens, proximately, to take all of humanity down with it in its death-spiral, into a new, and this time final, "Dark Age".

We do not pretend that the enclosed text is more than a draft. But it outlines a comprehensive alternative socio-politico-economic system to that of the present. We have no doubt that you can improve upon it. If you see that you can, please do so, and please propagate your improvement, with or without any attribution to this source -- your choice.

We have no proprietary relationship to this proposed successor system, and we are pledged to anonymity in all of our work on its behalf [for more on our covenants in this regard, please see the text at the following URL --
